Current Issues in the sector

- Application by the ANMF for wage increase to the Nurses Award 2020 by 35% joint private sector approach to this issue.
- Discussions with Minister Butler's office and the Department of Health and Aged Care led to a decision that General Use Items will remain on the Prostheses List and therefore will be covered by Private Health Insurers.
- Discussions with Health Ministers and jurisdictional Departments of Health regarding outsourcing of public hospitals elective surgery back log to day hospitals that can provide cost effective and efficient way assist in the reduction of this backlog.
- Dissemination of the Briefing paper and outlining the importance of a fit for purpose accreditation system that better reflects the model of care and specialised nature of day hospitals. Working with the Federal Minister's office on a recognised consistent national Definition and Terminology in relation to Day Hospitals – continuing engagement with jurisdiction Ministers and Departments of Health on the issue.
